Application for Catastrophic Benefits

Please Note: In order to qualify for benefits, applicants must fulfill the following qualifications:

- 1) You must either (a) reside in the Annapolis area or (b) have gigged in the Annapolis area at least 18 times during a 12-month period from the date of the application, or (c) have a demonstrated and long-term commitment to and involvement in the Annapolis music scene.
- 2) You must have experienced a catastrophic event within the preceding twelve (12) months, such as (a) a natural disaster, (b) a medical emergency or (c) a debilitating disease or illness.

If you qualify, complete this "Application for Catastrophic Benefits" and submit it to AMFM.

Once received, AMFM will review your application and respond to your request.
