

*Annapolis Musicians Fund for Musicians, Inc., is a non-profit organization created to provide temporary financial relief to professional Annapolis area musicians who cannot work due to sickness, injury, or any other circumstance leaving them unable to perform. This fund acts as an emergency relief fund for lost income.*

## **Application for Lost Gig Benefits**

In order to qualify for lost gig benefits, the applicant must either reside in the Annapolis area or have gigged in the Annapolis area at least 18 times during a 12-month period from the date of the application. For example, if an applicant submits an application on June 14, 2024, the applicant must have gigged 18 times within the 12-month period from June 14, 2023, to June 14, 2024.

AMFM defines "the Annapolis area" as the following zip codes: 21401, 21402, 21403, 21404, 21405, 21409, 21411, 21412, 21012, 21032, 21035, 21037, 21106, or 21140.

If you qualify, complete this "Application for Benefits" and submit it to AMFM.

Applications must be submitted within 6 months of the date of the lost gig.

Once received, AMFM will review your application and respond to your request.

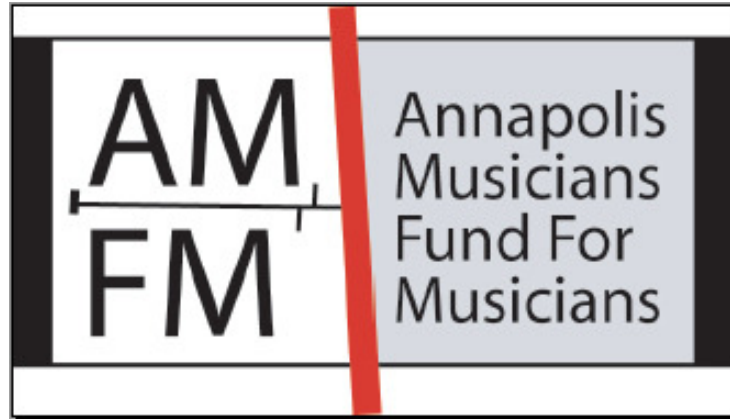
